NOTES

The Incumbent of the parish shall be ex-officio the Chaplain of the parochial unit formed in their parish.
 The Incumbent may nominate another member of the clergy, or a licensed reader or accredited church youth worker, or other suitable person to fulfill that role for appointment by Brigade Council.
 The Incumbent may nominate Assistant Chaplains for appointment by Brigade Council.
 In the case of a Company formed in connection with Missions, Schools, Institutions or extra-parochial organisations where the Administrative Head is not in Holy Orders, they shall nominate a Chaplain and, if they so desire, Assistant Chaplains for appointment by Brigade Council.
 Where the Chaplain is a member of the clergy he or she shall have Permission to Officiate in the Diocese in which the parochial unit is situated.
 Where the Chaplain is a layperson he or she shall be a communicant of the Church of England or a church in communion with the Church of England.
